**Re: CCA s. 22 Notice and Amendment of Long-Term Care Home Service Accountability Agreement (“Amendment Letter”)**

The *Connecting Care Act, 2019* (“CCA”) requires Ontario Health (“OH”) to notify a health service provider when OH proposes to enter into, or amend, a service accountability agreement with that health service provider.

OH hereby gives notice and advises CVH (No. 6) LP by its general partner, Southbridge Care Homes (a limited partnership, by its general partner, Southbridge Health Care GP Inc.) (the “HSP”) of OH’s proposal to amend the Long-Term Care Home Service Accountability Agreement (as described in the CCA) currently in effect between OH and the HSP (the “SAA”).

Subject to the HSP’s acceptance of this Amendment Letter, the SAA will be amended with effect on **April 12, 2023**, as set out below. All other terms and conditions of the SAA will remain in full force and effect.

The terms and conditions in the SAA are amended as follows:

- 1) Parisian Manor has been removed from the Multi-home LSAA.
- 2) Southbridge Cornwall has been added to the Multi-home LSAA including Schedule A.

Unless otherwise defined in this Amendment Letter, all capitalized terms used in this letter have the meanings set out in the SAA.
